## *Chairman's Message*

### *Planting that yield edible fruits*







Nothing is more beautiful than the moment that you inspect a seed that you've planted twenty-five years ago, to find it has become a towering tree, hanging its good, in away accessible to those who need and deserve it , and when I remember those humble beginnings that accompanied the emergence of " Beit Al Khair " and see what we have reached now, I feel thrilled , I and my brothers who accompanied me in the way of charity, which we are celebrating today the 25th anniversary, before we used to be happy when our giving reaches a few tens of thousands, and here today we are celebrating that our spending has exceeded one billion, and benefited thousands of families, widows, orphans, indigents, disabled and the sick , and others of special needs , and I thank God Almighty that the society has always been able to fulfill its obligations and promises, and provide monthly assistance and emergency always resolved and provided in time and on demand .

Charitable and humanitarian work is inherent in the people of the UAE since ancient times , but it was dependent on the initiatives and individual efforts, and the people believe in the so-called " FAZAA " in doing everything, which means people have to join to help those who need help, such as building a house, processing of the wedding, to extinguishing fire, benefitting the poor, sympathizing in the catastrophe, and they sometimes form up committees to temporary resolve humanitarian crises, emergencies , and then dissolve these committees as soon as the crises are contained , by this time the idea of creating a society that specializes in philanthropy within the state was born, to be organized on a permanent basis, we wondered together "Why we do not turn temporary committees into a permanent sustainable entity, especially as humanitarian cases exist in every place and time, and the giving is not an Endowment(Waqf), " and soon that question was thought of and well received by a group of friends, we agreed to establish a charitable society in 1989 and we called it, House of goodness , "Beit Al Khair ".

It was not the first time that I thought of the establishing a society specialized in charitable fields, before the Union in 1956, I established with my partner Mohammed Alkaz a charity aiming at providing assistance to the needy in that time, this has contributed to many events, though it was infant with limited income, and we vested its management to Sheikh Mohammed bin Hadder.

Then , the State of the Union was established , and a lot of ideas and experiences has accumulated which I decided to be implemented through " Beit Al Khair " , and the first Board of Directors of the society consisted of seven members : Nasser Abdul Latif Al Serkal , Ahmed Mohammed Bu Rahima , Khalifa Juma Al Naboodah, Rashid Abdul Aziz Almukhawi, Mohammed Ibrahim Obeid-Allah, Abdul Rahman SaifAl Ghurair and Abdel Wahed Hassan Al Rostamani , where I nominated Al Serkal to be the President of the Society, but he apologized and insisted that I should take over the presidency, then we have chosen him as vice president .

Fortunately the Board of Directors have not encountered any obstacles or problems during this period , where every member participated with their money and efforts in supporting the infant society , also people trusted the role of society so they gave it full support in order to play its role in serving their community, especially as it was directed to serve families within the state, and raised the slogan of " it is from the UAE to the UAE ," but what we considered as a problem, is some are seeking help, but actually they do not need it, they just aim at getting money, so we suffered some times , till those understood that donations and Zakat assigned to the poor and the needy people.

But a truth to be told is that, the charitable work in the UAE has evolved a lot, and grown and developed to be the leading experience all over the Arab and Islamic world, and it requires us to strive more to maintain this exclusivity, and to be creative in our work and not only imitators.

" Beit Al Khair " , insisted on its approach which is the specialization in charitable work within the state , and has proved the validity of its aims and directions, and after twenty-five years , proved that its choice was right , and that the society role was needed, and filled a gap which some people thought to be only as responsibility of the state, and provided a model for Non-Governmental Organizations in integration with official efforts, and we shouldered our societal responsibilities for our own community.

And hereon and today, " Beit Al Khair " celebrates the passage of a quarter century of giving and great achievements , which calls for pride, the society has proudly, until today, expended more than one billion and one hundred million dirham, and





won several awards and recognitions and was awarded the " ISO " quality certificate and has become a lesson for sister societies and counterparts in the Arab world , and won the confidence of many donors and partners, who did not fall short in supporting the society's programs and schemes, and I take the opportunity of this occasion to extend my thanks to all the benefactors and philanthropists and owners of helping hands and to the businessmen and the individuals citizens and residents in the UAE, and to each and everybody who served this society throughout its long history.

I would like to convey my special thanks to our charitable strategic partners led by the Al Maktoum Charity Foundation, and its president, His Highness Sheikh Hamdan bin Rashid Al Maktoum, Deputy Ruler of Dubai, Minister of Finance, I would also would like to thank Dubai Islamic Humanitarian Foundation, Sultan Al Habtoor Foundation, Al-Futtaim Charities and all the other people of generosity and initiatives.

I will not miss to direct tribute and appreciation to all who contributed to the march of " Beit Al Khair " with their endless support, efforts and new ideas, till it is grown fruitfully, I thank them for what they have given and have made and for being faithful, and blesses for those who passed away, pray for God to reward them and accept their good faith.

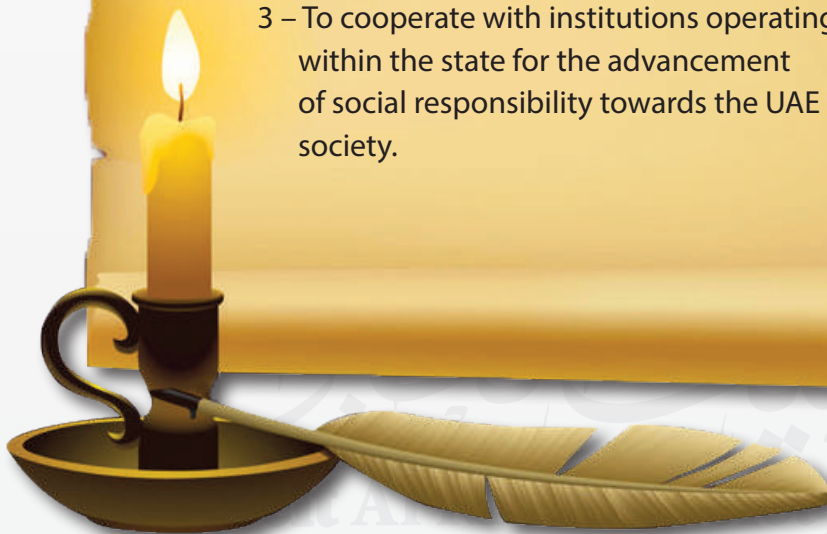

## *Beit Al Khair « A Success Story »*







With the emergence of the Federation of the UAE, and the flow of oil revenues, conditions of the people improved, and prosperity spread throughout the state, but that did not prevent the failure of some of the families in trying to keep up with this development, who were not able to improve their income for one reason or another, in addition to some of the vulnerable groups, who form a part of any society such as orphans, widows, divorced women, the elderly and others. So, HE Juma Al Majid , who was known for his sense of humanitarian and charity and his helping hands, took the initiative to establish public benefit society, specified to perform within the state, to realize that he invited and called for a number of business men and the people of the charity whom he trusts and who are active in the fields of goodness, and well known the UAE to society, all of them positively responded to his initiative , and they welcomed the idea enthusiastically, and when they thought of a name for the new coming society, that was already formed by the founder of the idea it was .."Beit Al Khair"...it came suddenly but remained as a saying and ongoing example, the slogan selected for the newly born society is" an old Arab house door," a symbol of the warmth of the message carried by this society, and submitted to the community as a habitat and haven for all weak and needy people in the UAE, those who seek help and assistance.



## *The beginning and the official publicity*



As the founders recall with pride and satisfaction, that was exactly at five o'clock Monday evening, the second of January 1989, when the first meeting of the founders was convened for the distribution of administrative offices, to register the society in the Ministry of Labor and Social Affairs, and it was agreed unanimously on the name, and approved the memorandum of society and the application for the establishment of the society was sent to the Ministry of labor and Social Affairs, the approval came under the Ministerial Resolution No. (41), dated 29th of March 1989, and the first Board of Directors of "Beit Al Khair" comprised the following:

To be fair, those men have endeavored and performed their tasks faithfully, and doubled their goodness to begin such public charitable society, and realized and achieved the humanitarian and charitable objectives, and covered the target of public interest that the society is established and initiated for, and to provided help and assisted for each of the eligible citizen of the United Arab Emirates.



### *The Performance Strategies of the Society:*



- To compliance with the rules of legitimacy ordered by God in philanthropy and financial transactions.
- To comply with laws governing charitable activities within the United Arab Emirates.
- To limit the activities of charitable and humanitarian and relief within the state.
- To meet the needs of the less fortunate and income within the UAE society.
- Cooperation and coordination with charities operating in the United Arab Emirates.
- To adopt the latest tools and techniques in the management of charitable work.
- To launch programs and schemes based on rigorous studies to monitor the real needs of segments and beneficiary groups.
- To adopt social surveys for the study of families in need, and the conditions of lower-income groups, and continuous updating of data.
- To take into account the privacy of families and situations while dealing with them during the study or assistance in accordance with the values, customs and traditions of the UAE society.
- To target helping the family as a whole, not just individuals, giving them a chance for happy life and dignity.
- To build partnerships, integration and cooperation with charities and public benefit organizations.
- To observe self-criticism and develop the performance constantly to achieve the highest possible level of performance.

### *Quality Policy*

1. To comply with the requirements of quality system.
2. To achieve goals.
3. To provide and develop services regularly and continuously, in order to satisfy all categories of customers.
4. To comply with the laws and regulations governing charitable work, and commit to transparency, clarity, and the principles of corporate governance.
5. To review and evaluate the general framework of the quality system and improve performance.
6. To publish quality policy for all categories of customers through various means and check out their familiarity to the same.

### *Escalation of spending rates*

Since its establishment, " Beit Al Khair " in smooth thoughtful and well studied planning , and this approach have achieved the best results, and started reaping success after another, from three employees at the beginning of the society to such a large number , which exceeded today above 300 staff and volunteers , and from one branch in Dubai to branches and centers spread across the UAE, and from a modest spending that didn't exceed a few million in the early years to an annual expenditure in 2013 amounted 151 Million Dirham, and from a single humble main office, to the headquarters and the offices of a high degree of precision and to an organization, managed according to the latest management systems and technology, and with the aid reaching the intended recipients through electronic bank cards, the beneficiary could use it as any credit card benefiting from cash withdrawals and paying bills and shopping , without being forced to take the trouble to access the society's offices, or waiting for the service, to receive assistance or assessments, and so on .. the society moved from success to another, until it became the most prominent on the field of charitable work in the UAE.

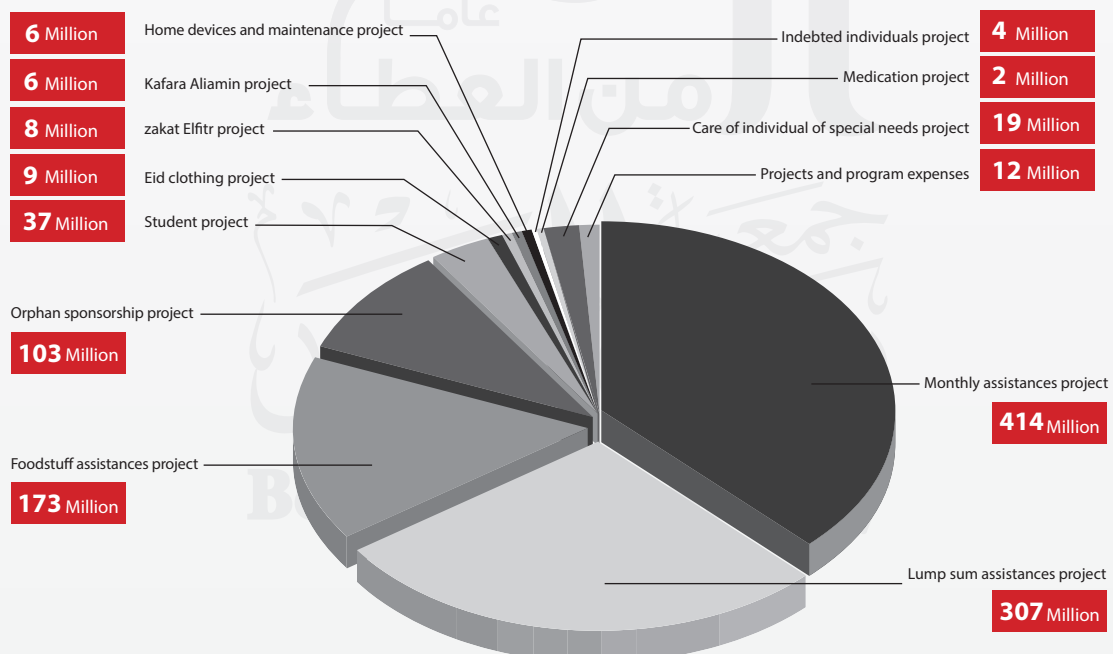

### ISO certification

In a talk of memories with Mr. Yasser Abdullah Hpennekah Al Midani, the first employee in Beit Al Khair, he said that: The society had encountered many difficulties at the beginning, most important the process of reaching the needy families, due to the chastity nature of the people of the UAE preventing people from expressing their poverty. So we started looking for those needy families through the schools, we assigned to the social specialists in schools to notify us about the students seem to be needy, and through them we accessed their families to provide them with assistance, then we started to design the registration forms, research and in order to organize complete records for each case.

He adds, the actual beginning and the major task that reinforced the knowledge of the employees of the of the society, was the role played by the Society during the Iraqi invasion to Kuwait, where the Society opened its doors to Kuwaitis who fled to the UAE, that was when HE Juma Al Majid launched his great sayings: " Now Open the files of our brothers the Kuwaitis to us - it's time to give back. ". So the Society hosted some 300 Kuwaiti families, and provided them with full care, housing and food, under the direct and daily supervision of HE, the budget of the Society during the Kuwaiti crisis reached four million dirham, and despite this we were confronted with a shortage in the provision of adequate financial resources, because of the large expenditure, but a man of good and attitudes HE Juma Al Majid passed urgent instructions to utilize his personal treasury as extension to the Treasury of the Society to ensure that no services shall stop even for a few moments, yes, this is Juma Al Majid , a flag upon the good society in the UAE and the Islamic world as a whole , a person inherent to philanthropy.

The Mohammed Bakkar Bin Haider held the office of the General Manager of the Society between 1992 and 2006, he followed the march stages of the Society during the formulation of the administrative system and institutional framework for Beit Al Khair, his era was marked by a period of hard work where young people were recruited by the Society, and the range of activities expanded by establishing four centers, during that period " Beit Al Khair " moved to its new headquarters in Dubai, also Fujairah branch was opened, the eastern region followed by the branch of Ras Al Khaimah, four centers in Dubai under Al Maktoum Foundation operated by the Society for the benefit of the needy in Dubai

During his regime the society managed to obtain the ISO certificate for the first time in the history of charity work not only within the UAE, but also at the level of the Gulf States. He was a distinguished and known for his creativity in his work, endeavored to ensure cooperation with the members of the Board of Directors, and gain their trust and support, his efforts were appreciated by everyone in the Society.

## Mohammed Ali bin Zayed



Mohammed Ali Bin Zayed Al Falasi, a member of the Board of Directors of Beit Al Khair Society, since its infancy, was one of the young talents adopted by Beit Al Khair, now he is the deputy governor of the UAE Central Bank. He recalls and praises the members of the Board of Directors, pays tribute to their leading role to the development of the resources of the Society, its management and its presence at the local and regional level, its development encouraged to establish charities in many countries, which are rushing out to take advantage of "Beit Al Khair" rich experiences.

He says: I remember when I suggested that the society should operate on a quest to obtain ISO certificate of quality , all the Board Members welcomed the idea , and every-

one worked hard and gave everything he could tirelessly, thus, "Beit Al Khair" got the international quality certificate, which confirmed the evolution of this Society and the success of the charity and the administration , I was delighted and honored at a personal level that I worked with those great men, who thought and founded Beit Al Khair Society which is led by Juma Al Majid, Abdul Latif Al Serkal, Mohammed bin Abdullah Alkaz, Mohammed Ibrahim Obaidullah, Abdul Wahid Hassan Al Rostamani and Khalifa Juma Al Naboodah , who thought to help orphans, the poor, widows, divorced women and other cases, for whom the society must cooperate together . Those founders moved from the individual effort by each person to an institutional organized effort.

I remember that , some people doubted that the Society would continue its march, and would be able to increase its resources, but, thank God, by the sincerity of intentions, resources multiplied every year, and charity started growing in the UAE , and I ask God to reward all those who participated in the establishment of such society worked together to mitigate and alleviate the suffering of the needy, and common solidarity and cohesion in the Muslim community, and I wish that Beit Al Khair Society will succeed in training leaders in the field of philanthropy, and ever I dreamt that there would be special training courses for volunteer and employee, that developed to the global performance standards, and to achieve transparency.



## *Zuhdi Al-Khatib*



Zuhdi al-Khatib was one of the early employees who engineered the tracks of charitable work in the Beit Al Khair Society, he was introduced and adopted Juma Al Majid, the Founder and Chairman of the Board of Directors of the emerging infant society after he assessed the talents, administrative abilities, his participation and his role in the prosperity of Education in Dubai and his initiative in education renaissance in UAE .

It is worth mentioning that Mr. Al-Khatib was one of the pioneers who established formal education in Dubai and the UAE , under the supervision of the late Sheikh Rashid Bin

Saeed Al Maktoum, which was launched in the academic year 1955, also served as a delegate to UNESCO in the UAE, to oversee the adult education centers affiliated to the Ministry of Education, then became the Head of the Advisory Office of the Minister of Education, responsible for educational missions .

Mr. Zuhdi Al-Khatib, was known as a leadership among the team who established the unique approach of the Society in support of needy students, and was the second official in the Society during its infancy, according to Mr. Abdeen Al-Awadi, Al-Khatib was one of three staff running the Society when he joined them in 1990.

## Dubai branch



Dubai branch was founded with the emergence of the Society, and is located in the headquarters of the Society in Al Nahdah-Dubai, having the largest section for research and social assistance, where all charity requests are received, studied and audited for the distribution of aid in cash and kind, and then the study and follow up of the evolution of the situation and what undergone periodically for each case.

The branches serve the emirates of Dubai and Sharjah, and are characterized as covering the largest number of cases served by the Society.

### *Fujairah Branch*



Founded in 1998 and serves the East Coast of the United Arab Emirates. Fujairah branch serves several areas, including: Emirate of Fujairah, Dibba AlFujairah, KhorFakkan, Kalbaand Dibba Al Hisn.

### Al Maktoum Charity Centers

A strategic partnership agreement combines Al Maktoum Charity and "Beit Al Khair", through which the Authority entrusted to the society the general administration of four charity centers set up in the Emirate of Dubai in 2003 to receive requests for support and assistance from citizens in those areas, which are: Aweer, Allisaly, Hatta and Al Barsha, also the society is entrusted to care for orphans who were sponsored within a scheme dedicated to the orphans, both organizations entered in a partnership agreement for the care of people of special needs, where Beit Al Khair after the opening of these centers embarked on the process of selecting and training the staff that have already been employed, and the application of management standards used in the Society, the distribution of Zakat and donations, the implementation of all programs and schemes, operating them as additional channels of Beit Al Khair in Dubai.

*Searching for the most needy people*



The motive behind the establishment of " Beit Al Khair " from the beginning was to provide aid to the needy in the UAE, and advance their economic and social positions in order to achieve solidarity, establish social security, the Society has always been concentrating on providing assistance to the most needy people, and made this its slogan, adopted a modern system for social research, aims at investigating how serious is the situation, the needs of low-income groups, seeking help, verify their data, and visit their homes to be acquainted with their actual conditions closely.



### *Qualified female Researchers*

The work of social research in the Society is entrusted to qualified female researchers, who are knowledgeable about the specialty of Emirati family, and they are subject to constant training and guidance to carry out their role effectively. Those researches receive ongoing guidance from management, not to over question about the secrets of families and to respect their privacy, and to confine themselves to general conditions only, and that the visit should be friendly, researcher have to speak kindly with regard to the encouragement of the candidate on the disclosure of their circumstances and suffering , must inform people that these visits are only to check the family in order to provide assistance only, all information collected by researchers shall be maintained in full confidentiality and accessed only by the concerned staff.

## *The Broadest Database*

"Beit Al Khair" has been characterized by "capabilities and expertise in social research, and has become a source of expertise and experience in this area, and an example for several charities, which ask Beit Al Khair to provide training courses to its staff in this aspect, "Beit Al Khair" has accumulated through a quarter of a century a rich data base containing more than 30 thousand cases, which are available for all institutions or bodies need in order to study or for charity coordination . The Department of Social Research in "Beit Al Khair" updates this data electronically and today it possesses the most authoritative electronic database in the UAE for families and groups that deserve support and assistance .

## Programs and schemes



"Beit Al Khair " in deciding on its programs and schemes depends on thoughtful in-depth studies, by conducting social research to determine the most urgent needs, or those most deserve help, and accordingly search for funding to cover the costs of the program or the proposed scheme.

### *Expenditure policy in "Beit Al Khair"*

" Beit Al Khair " is characterized by a strict and transparent policy of spending , to control funding the operations of its programs and charitable schemes, the Society scrutinizes the applications for assistance through a system of social research to make sure that charity spending goes to those who are most in need out of the target groups, through a series of actions that always subject to revision, to make sure of their usefulness, always looking forward to designing new procedures that constantly updated, to be fairer , easier, more accurate and convenient to those who are seeking help ..



## Disbursing Aids

"Beit Al Khair" Since its inception in 1989, was keen to maintain the accuracy of the work, and the order of the finite in the delivery and distribution of aid, and avoided the distribution of direct cash assistance, and insisted that any aid offered by checks to be signed by two authorized at least. Thus, giving the Society credibility and confidence among donors, "Beit Al Khair" is the first society provides assistance through checks, which contributed to sustain its success over a quarter of century.

## "Beit Al Khairbanking card"

During 2013 in collaboration with the Commercial Islamic Bank of Dubai "Beit Al Khair" developed a system to update its procedures and financial transactions, and to make it easier for beneficiaries, by the adopting "Beit Al Khair" Bank Card, thus, being the first and the only Society within the country and in the Arab world that goes into such service, for the disbursement of financial aid monthly, and also for the salaries of staff and volunteers, through accredited credit cards for transferring monthly assistance regularly.





### *The most important programs and schemes:*

#### *First - The Needy Families Program*

The program includes:

##### *1 - The monthly cash aid scheme:*

Through this program the society provides monthly financial aid to low-income families, the aid depends on the location of residence, the rate of household consumption, and fixed and variable income.



##### *2 - Families Sponsorship Scheme.*

This aims to sponsor the needy families within the state, and provide a steady income to them, with special controls to maintain the confidentiality of the information and the dignity of the families, without specifying a particular family to the sponsoring party, in order to preserve the confidentiality of information and the dignity of the families, these households receive monthly aid under the same previous standards.

### 3 - The monthly in-kind and food materials scheme:

Through approved-cards, the society supplies foodstuffs from cooperative societies on a monthly basis to families thought of as improper in the disposition of cash. Under this type of assistance comes; Ramadan assistances (Meer Ramadani), foodstuff coupons provided to support on monthly basis to purchase from the cooperative societies approved by the Society, in addition to the meat of ( Eid Al Addha ) slaughtered by philanthropists and distributed to needy families .

### 4 - The scheme for caring after the families of people with special needs

This scheme provides assistance to the elderly, and people with disabilities who cannot earn a living to maintain their dignity and welfare where the amount for the disabled is added to the amount of assistance allocated to the family per month

### *5 - The scheme for caring the families of orphans*

The Society provides monthly assistance to the families of orphans, whereupon the society collects the amount for each family, and provides it in the name of the parent or guardian of the children through the official authorities, the expenditure on families of orphans' falls within the orphans program, which will be explained hereunder.



### *Secondly - Orphans Program*

It includes several schemes:



### *Sponsorship and care for orphans*

This scheme aims to find a sponsor for each orphan to take care of all the requirements and affairs till is independent , the scheme notifies the sponsors of the real needs of orphans, and the additional aid that enhances their physical, psychological and social position, especially during holidays and seasonal events, and at the opening of schools, the Society adopts the male orphan until he graduates from the university, and engages the labor market, and the female orphan till marriage .



### *Orphans Fund Scheme:*

The idea of this scheme was formulated due to the multiplicity and variety of orphan needs escalating gradually throughout the growing stages of the orphan from childhood stages to the following stages, which requires the presence of a sufficient resource of stable fund to cover both the permanent and emergency needs that fall under other aspects of care.

### *Orphan Eid bonus*

This is a sort of a cash gift provided by philanthropists just before the approach of Eid al-Fitr and Eid al-Adha every year in order to satisfy the orphan needs and bring joy and pleasure to them on this occasion.

### *Thirdly - The student program*

This program consists of two major schemes:

#### *The stationery "The school Coupon" Scheme:*

This scheme aims to provide stationery and school supplies for the male and female students as participation from the Society in support of the educational process for those needy students, which is an improvement to the scheme called "The school Bag", it is provided to the student in the form of coupon to be exchanged with school stationeries required by the student within the specified value of the coupon.



### *Tayseer Scheme “for university students”*

The scheme stems from the importance of follow-up and support for university students and to help them financially or in kind, or both, until graduate from the university, or institutions of higher education, and support higher educational programs by any tools needed by poor students, such as computers, and the preparation of graduation studies and research, in addition to support transportation, and cost of living for needy students.

The Society has joint cooperation agreements with each of the Zayed University and the Higher Colleges of Technology and the Faculty of Arabic Studies in Dubai, particularly in support of the female students.



The total expenditure on the student's program amounted

37 million dirham

### *Fourth: the “ongoing charity”*

It consists of the following schemes:

#### *1- Charity Endowment Scheme:*

It is the main scheme, which “Beit Al Khair ” is emphasizing on promoting, ensuring the continuation of its resources, Beit Al Khair, has collated yet 18 endowment (Waqf) buildings, distributed within most of the emirates.



## 2 - Household items scheme:

This includes the following supplies (air conditioners - Refrigerators - Washing Machines - Furnaces).

## 3 - Maintenance of a home for a poor person:

### The benefit of the scheme:

- 1 - Each family or registered cases , and all those own home , proved as lacking main tenance through technical reports.
- 2 -Everybody whose home is in poor con dition , and hopeless of maintenance, or about to collapse.
- 3 -A lease holder for residence repelled and evacuated by force for inability to pay rent.

### Fifth: The seasonal programs and schemes

#### Zakat program

The beneficiaries of this program are the categories covered by the verse 60 of Surah Altoubah "Charities are meant for the indigent and needy, and those who collect and distribute them, and those whom you wish to win over, and for redeeming slaves (and captives) and those who are burdened with debt, and in the cause of God, and the way-farers: So does God ordain. God is all-knowing and all-wise."

Every year the Society conducts an administrative and accounting program, depends on ensuring the needs of targeted households of this scheme throughout the year, through a package of schemes and programs which are permanent and seasonal, and other schemes waiting for adequate fund to be implemented.

### Ramadan Meer:

"Beit Al Khair", was a forerunner to the launch this idea that upgraded the program known as "Ifftat Saem" into a program to finance the food needs of the fasting in Ramadan to enjoy within his family, the society has prepared an administrative and accounting program to ensure the needs of targeted households of this scheme, and is based on:

- Ensuring food parcels full of all the basic needs of the family breakfast throughout the month of Ramadan.

- Exchanging coupons and electronic multi-value cards, for families registered in the Society, whereby receipt of food - as desired by the state - from cooperative societies and supermarkets.

The expenditure on this scheme falls within the food aid, and in addition to, Zakat al-Fitr.

Eid donation "Eidia" is also classified within seasonal programs, which is a cash gift of provided by the Society at the Eid al-Fitr and Eid al-Adha and fasting expiation, and initiatives of orphan Ommerrah, Eid al-Adha sacrifices and other assistance related to annual and seasonal occasions.



## Programs and other schemes



### Expiation “Kaffarat Yamin”

The Society adopted the estimations of the Department of Islamic Affairs and charitable work to pay the amount of fifteen dirham per poor person, issued as a coupon worth AED 150 as “Kaffarat Yateem”. In response to the Quran guidance “Allah does not impose blame upon you for what is unintentional in your oaths, but He imposes blame upon you for what your hearts have earned. And Allah is Forgiving and Forbearing”...

### “Debtors’ “Fund Scheme

This is a new scheme began in 2010, the debtor “Gharim” needs to submit proof of the value of total debt and maturity date, given that it was not spent in sin, or bad things, therefore, then time to goes to God and repent, and undertake in writing to the Society that he will do the same again, and upon completion of the terms, the Society will negotiate the owner of the debt on his outstanding credit, and he can let it go of it, then you pay the debt to the owner directly, by due process of law.

### “Kadimakum Jdidahum” Scheme : (For you it is old for them new)

“Kadimakum Jdidahum” Scheme : (For you it is old for them new)

This is a recent scheme began in 2011, where old clothes and needs are collected for the benefit of needy and low-income people, and it is sold to recycling companies to accumulate the proceeds to help needy families, part of the proceeds is allocated to the scheme known as Eid clothing.

#### Eid Clothing:

Amounts that result from this project are to be expended on Eid clothing to needy families during the Idi-Fitr and Eid al-Adha.

#### Eid Dressings:

This fund is allocated for Eid clothing to needy families during the Idi -Fitr and Eid al-Adha.

### ***"Medication Project" Scheme "ITAJ"***

It is a new scheme launched in 2011 by "Beit Al Khair" in cooperation with Dubai Health Authority, to help residents who are in need of treatment but unable due to their low income, this assistant has the following pre-requisites:

- To submit proof of his inability to pay for treatment.
- To give his medical reports or prescriptions to prove his condition and his need for treatment or medication.

### ***Lump sum aids***

These are one time emergency payment allocated for those facing special circumstances which constitute an additional burden on families receive a monthly aid, inclusive of some seasonal assistance like Eid Gifts and freeing prisoners and etc...

## *The Society Fund Resources*





### Firstly: Zakat

Zakat is a cornerstone of Islam, and must be paid on time when due, the beneficiaries from zakat are the categories covered by the verse 60 of Surah Al-Toubah, and constitute the highest percentage of the resources of the Society, and the payer of the Zakat may select the category that he would like to spend on them, if he wishes.

The total amount spent by the Society from Zakat funds from 2014 - 1989 amounted around 57 % of the total expenditure, which amounted to one billion and hundred million Dirham.



### Secondly: charity "Sadaqatt"

It is one of the basic sources, which supports programs and projects of "Beit Al Khair" which includes handouts and donations by benefactors, the amounts collected from the Society funds, the value of charity coupons, and the proceeds of charitable endowments. The percentage of the proceeds of charity and endowments in 25 years amounted %39 of total revenue, In addition to 4 % generated from other sources.



### Thirdly: Endowments

"Beit Al Khair " found this source safer in term of resource fluctuations and lack of fund stability. Endowment in "Beit Al Khair " developed to grow well, the Society today is aiming at a strategic goal to increase the income from endowments during the few coming years to reach half of the total income.



#### *Fourthly: Cooperation and integration of partnerships*

"Beit Al Khair " is involved in many strategic charitable agreements with a number of organizations and institutions, such as "AlMaktoum Charity" which has taken "Beit Al Khair " as its charity advisor and has entrusted to the same the management of four of its centers within the Emirate of Dubai. This is a new means to donate which is recently introduced, where the donor can donate through different credit cards, and SMS messages in agreement with the telecommunications company.

### Spreading Donation Outlets

The Society sells coupons in shopping centers and cooperative societies in the country, to promote for the Society projects, and for the distribution of saving boxes in all shopping centers, public utilities, government departments, and there are several types of them.







### *Depositing boxes and donation machines*

Electronic donation: "Beit Al Khair " always is seeking to modernize its methods and tools, during 2012 it launched a new device to collect donations via its external points scattered throughout the state, and the new device to collect donations giving the donor a free chance to decide and select where to spend his contributed donation .

### *"Attaya" Device:*

It is a typical ATM and can be dealt with a touch on the screen... It was produced and supplied to charities in Dubai. It is granted by His Highness Sheikh Mohammed bin Rashid Al Maktoum, UAE Vice President, Prime Minister and Ruler of Dubai in 2010.

### *Other types of deposit boxes "Alhsalat":*

The Society has large numbers of traditional fixed deposit boxes and which is distributed and discharged within a monitored mechanism and accurate accounting system , as the inventory system of the boxes "Alhsalat" has been updated with the adoption of barcode letters that gives accurate data for each box located anywhere.

Few of the most important donation devices used by the society are: The semi-automatic donation machine which is typical to the ATM composed of nine boxes –or a large box single or dual cells – or large or small donation counter –or easy donation box – containers for used clothes - cardboard containers - counter house.

### *Management in “Beit Al Khair”*

Management in “Beit Al Khair” and the quality of administrative leaders who took part in different Boards of Directors or executive leaders is considered as one of the main reasons for the success of the Society. The organizational structure, the flow of command and the process of decision making in “Beit Al Khair” are following an elaborate system which is compatible with the law of charity institutions.

### *The Board of Directors :*



It is the highest body exercising the administration of the affairs of the Society, which is responsible for developing frameworks and policies adopted by the general assembly of the Society in accordance with the vision, objectives and specialization and all that would set the pace of work in the Society to carry out its charitable and humanitarian activity and achieve its objectives.

The Society Board of Directors includes a group of businessmen and the elites of Dubai, and the owners of white hands, who are experienced in charity work.

### *The Executive Committee:*

It is a sub-committee of the board of directors entrusted with monitoring the implementation of public policies and the decisions made, and address any new issues.



### *The Executive Management:*

It is the administration which will exercise the daily administration work of the Society according to the guidelines, rules and plans approved by the Board of Directors.



### *Human Resources*

" Beit Al Khair " is keen to choose its managerial, technical and supportive workforce out of the most qualified , skilled and experienced candidates who own experience and conversant in charity work, and workers are divided into types :Hiring a full-time (permanent employee) : They are mostly active and competent citizens.

- Permanent employees: Mostly skilled and qualified citizens.
- Partial temporary employees :( volunteer / day rate) they are volunteers who cover specific tasks versus reward.
- Temporary employment (delegates): they are mainly volunteers who are standing at the counters and in the coupons outlets.

### *Credibility*

### *Transparency*

The accurate financial system that has been developed to govern the set of data, revenue, payments, and strict accounting audit, is the base for the credibility and transparency that has grown confidently in the minds of donors, believing that the zakat donations they are paying and their charity go in the right track, and to the most poor people , in addition to government regulatory reports which refer to the extent of efficiency in the secretariat and management in the management of the funds received by the Society, and its eagerness to provide reports and information on what it spent that fund, whether they the reports sent to the donors or to strategic partners , or to the government regulators , which oversees and regulates the performance of charities.



### *Increased reliance on Smart Systems*

" Beit Al Khair " through the march of a quarter of a century has accompanied the every technological developments and information, adopted electronic archiving system, conducted a process of linking between various of its branches and centers , and used the Internet on a large scale, and confirmed its presence on all the famous social networking sites, the most interaction with the public , broadcast messages and promote projects , began introducing smart systems to the Society in response to the call of His Highness Sheikh Mohammed bin Rashid Al Maktoum, UAE Vice President, Prime Minister and Ruler of Dubai , transforming the emirate into a smart city , and was the last initiatives in this direction was the launch of " Beit Al KhairE-card " which canceled the traditional system for the distribution of aid , and turned it into an intelligent and easy system.

### *Community Network Relations*

Through the relationships built and maintained by " Beit Al Khair " throughout twenty-five years of activities, initiatives and campaigns, various visits to communicate continuing with the elites of UAE businessmen and philanthropists, honoring donors and collaborators, on what they gave and supported, and the delivery of their charity and zakat donations to those who deserve it, thus, " Beit Al Khair " was able to build a supportive social network, also dealt openly with guests, entities and institutions to familiarize themselves with the experience of the Society and its mechanisms, and receives Society organizations and bodies from outside the UAE those who heard about its experience, and sees it as an advanced model of performance and achievement.

"Beit Al Khair " is always keen on the selection and training of its staff, and enriched its cadre and with volunteers who are able to add quality in their fields, they have become a part of the system of volunteer work in the Society, this adding more abilities and additional expertise to the cadre

### *Encouraging Women Charity Activities*

The Society attracted a lot of female talents, and depended heavily on women in the processes of social research, as women occupy many of the administrative positions , and make up 60% of the staff and volunteers, as women make up an important part of donors in 2012 exceeded the number of women who have adopted orphans exceeded the numbers of men ( 526 lady of most of the emirates compared to 488 men) reflecting the entrepreneurial spirit superior to the women, women have sponsored 673 orphans.





### *Continuous training and organizing*

" Beit Al Khair " Since its inception is keen on developing the capabilities of its employees, and training them on scientific basis enabling them to carry their tasks with the thoroughness and the professionalism required , the society is committed to this developmental aspect , and provided for its employees and volunteers specialized training courses , both within the Society , or by sending them to external courses , to acquire and refine the skills and expertise and achieve the best results .



### *Organizing Events and Forums*

Beit Al Khair launches initiatives and organizes activities, which are in the development of charity work, such as organizing the first charity forum to achieve integration and co-ordination of efforts among the charities, and the organization of the graduates Forum to provide employment opportunities for graduates of the Faculty of Arabic and Islamic studies, and the university graduates of the daughters of poor families registered in the Society, orphans and forums for the advancement of this important segment.



### *Inculcating the culture of volunteerism among generations*

"Beit Al Khair" Society opens its doors to schools and universities introducing them to experience in humanitarian work and philanthropy , to inculcate a culture of good and volunteering in the hearts of the new generations , and " Beit Al Khair " organizes the schools orientation and training for students , and is urgently seeking to establish and promote a culture of volunteerism in the community as a humanitarian and social aims to benefit the public , and trying to attract every employer for charitable and humanitarian work.

### *Stability and Continuity*

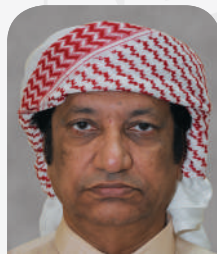
